Annual First Year Event

Law Ball

Our Law Ball was a great event this year. We were able to up our capacity with no extra cost, which is why the event did not 'sell out' as it has done in previous years. Unfortunately, we had some challenges with covid and last minute cancellations which affected the budget. However, I think everyone in attendance enjoyed their evening.

We also ran into issues as this was the first time the ball was not sponsored. This required us to be incredibly cost conscious and look at cost effective ways to manage the ball. For example, this year we made table decorations which was a saving of around \$1,000. It required a lot of extra hard work for those involved to ensure we were reducing our costs where possible. It created a lot of work for myself, Kushal, Olivia and Ryan with organising all of this, however, it did allow us to keep our ticket prices as low as possible.

Additionally, venues do appear to be charging more for food and beverage which needs to be a consideration moving forward. Furthermore, it is my recommendation for the 2023 committee to have a team dedicated to organising the ball and dividing the work up as a lot of work can be involved. Schedule 1: Responsibilities of the Socials Vice-President

It is the responsibility of the Socials Vice-President to:

- coordinate and facilitate social events held by the Society, including, at a minimum, an annual First-Year event, Law Ball and an End of Year event;
- coordinate and facilitate sporting events held by the Society, as well as the Society's participation in external sporting events; and
- coordinate and facilitate social and sporting events with other Law Societies and Associations in Western Australia.

It is the responsibility of the Socials Vice-President, as a member of the Executive Committee, to:

- proactively provide leadership and guidance to the Executive Committee, Committee and Sub-Committee;
- ensure that every Committee Member understands the expectations of their position, the objectives of the position and the objectives of the Society, whether outlined formally in this Constitution or informally in any other guidelines publicly published by the Society;
- represent the interests of the relevant Executive portfolio, Committee members and students;
- oversee the activities of the relevant Executive portfolio and delegate responsibility to the relevant Committee Member;
- assist the Committee in all endeavours, events and projects where appropriate; and
- work one (1) weekly shift in the Café of the Society in accordance with the appropriate By-law.
